About us

Kharkiv Institute of Social Research is a non-profit non-governmental organization that was founded in 1999 and is engaged in the development of an open civil society and democracy, respect for human rights and freedoms, and raising the level of legal awareness of the population of Ukraine.

For 25 years, we have been conducting research on socially important topics, analyzing the needs and problems of different categories of the population and advocating for their rights. JUSTICE AND ATTITUDE TO INTERNATIONAL WAR CRIMES

During February-March 2024, with the support of the United States Agency for International Development (USAID) within the framework of the Human Rights in Action Program, implemented by the UHHRU, the Institute conducted a study entitled **"Human Rights in the Process of Overcoming the Consequences of War"**. Residents of all regions of Ukraine participated in the survey. In total, 2,116 respondents. This study examined the possibilities of assisting war victims, the experience of internal displacement of Ukrainians, attitudes towvards residents of the TOT, respondents' awareness and assessments of coverage of information about the TOT and the war, their attitude towards collaborationism, and their opinion on reparations.

On June 5-7, 2024, the conference **«At the Turning Point of History: The Path to Justice for Victims of War in Ukraine»** was held in Lviv, where leading expert of the Institute of Human Rights and Human Rights Andriy Chernousov presented the study «Human Rights in the Process of Overcoming the Consequences of War: Results of the 2024 Survey.»

In the summer, a study **"Public Attitudes to International Crimes in Ukraine"** was conducted at the request and with financial support of the Ukrainian Legal Advisory Group. 1,119 residents of Ukraine were surveyed, as well as six focus group and in-depth interviews with people who were somehow affected by the war, and seven in-depth interviews with experts. The study made it possible to analyze the public's attitude to international war crimes, find out how witnesses of war crimes assess their safety, what kind of assistance victims of war crimes need, and generally study the issues of access to and trust in national and international justice.




NEEDS AND PROBLEMS OF DIFFERENT CATEGORIES OF THE POPULATION AT WAR

During January-February 2024, a survey of the population of the Velyky Burluk community in the Kharkiv region and the Shyrokivsk community in the Zaporizhia region was conducted at the request of the international humanitarian organization Médicos del Mundo. It concerned access to medical services and the main problems related to the health of the population. 400 residents of each community participated in the survey. In addition, in-depth interviews were conducted with the medical staff of these communities. The study allowed us to analyze the impact of the war on access to health services in rural areas and suggest ways to solve these problems.



In the summer, the Kharkiv Institute of Social Research also conducted several studies related to the needs of families of missing persons. In one of them, commissioned by the Kharkiv Human Rights Group within the framework of the project "Development of a Comprehensive and Holistic Approach to Providing Assistance to Missing Persons and Their Families", a survey of 500 family members of missing persons was conducted by telephone interviews, as well as 40 in-depth interviews: with experts (representatives of state authorities, public organizations) and family members of missing persons. The key needs of families of missing persons, their awareness of the rights, guarantees and procedures for searching for missing persons; sources of information about available services and guarantees; barriers to obtaining such services; assessment of the work of state bodies with missing persons and relatives; services that exist to support the families of the deceased and those found; the most problematic issues that concern the families of the missing. Another study, commissioned by the Ukrainian Helsinki Human Rights Union, focused more on the material, social, and psychological consequences of the disappearance of loved ones on adult relatives and children. It involved 14 in-depth interviews and a review of available assistance and services for families of missing persons.



PROTECTING THE RIGHTS OF PEOPLE WITH DISABILITIES

In July-August 2024, a study "Attitudes towards people with disabilities and supported living" was conducted with financial support and commissioned by the League of the Strong. It studied the real situation with the implementation of the social service of supported living in Ukraine in the context of the war, taking into account the growth in the number of people with disabilities, single older people and the realization of their right to live in communities on an equal basis with others. Representatives of institutions and social service specialists, as well as recipients of supported living services, participated in the surveys and interviews. 2,113 respondents from all regions of Ukraine took part in the study.






With the support of the League of the Strong, an analytical report "Supported Living and Supported Living in Ukraine from the Perspective of Deinstitutionalization Reform" was also published, which examined the real state of implementation of the social service of supported living in Ukraine in the context of the war, taking into account the growth in the number of people with disabilities, single older people, and the realization of their right to live in communities on an equal basis with others.

Also in the fall, a study of opportunities and barriers to employment of persons with disabilities (veterans) was implemented with the support of the Office for Economic Policy and Regional Development Ltd. 8 experts in the field of employment of persons with disabilities in Ukraine were interviewed and statistical and regulatory acts were analyzed. The results made it possible to present Ukraine in a comparative study together with a number of other European countries, as well as to actualize the painful issue of employment of persons with disabilities in Ukraine.

On November 1, 2024, Leading expert of the Institute of Social and Cultural Development Andriy Chernousov took part in the press conference «Deinstitutionalization and Supported Living: Is Society Ready for Change» by the public association «League of the Strong» to present the results of the study «Attitudes towards People with Disabilities and Supported Living.»



December 4-5, 2024. Andriy Chernousov reported on the results of a study of opportunities and barriers for employment of persons with disabilities (veterans) in neighboring countries and candidates for accession to the European Union within the framework of the international seminar «Employment Opportunities for Persons with Disabilities» in Milan, which was organized by the European Commission (EU DG NEAR) and the European Training Foundation.

ATTITUDE TO MOBILIZATION (CONSCRIPTION)

In March-April 2024, focus groups and interviews were conducted as part of the study **"Mobilization of Hearts and Minds in Wartime: Fears and Expectations of Ukrainians Regarding Military Service."** The study was devoted to studying the attitudes towards mobilization of representatives of various groups of Ukrainian society: men currently serving in the Armed Forces of Ukraine, civilian men; wives and mothers of military personnel and men of draft age, veterans, and young men who have not reached draft age. The study was conducted under the leadership of the Public Interest Journalism Laboratory (PIJL).






CHILDREN RIGHTS AND THEIR NEEDS

This summer, Save the Children commissioned a qualitative study of the educational, extracurricular, and quality leisure needs of Ukrainian children during wartime. The study included focus group interviews with middle and high school-aged children and in-depth interviews with parents and guardians. The findings enabled SCI and its partners to make more informed and timely decisions about the development and delivery of education programs for children living in war-torn Ukraine.

TAlso this year, the leading expert of the KhISR, Andriy Chernousov, participated in the creation of the White Paper **"Protection of Children from Forcible Transfer and Deportation"**. More than 15 international experts and organizations in the field of international law worked on the White Paper. This document reveals the systematic nature of the deportation and forcible transfer of children carried out by the aggressor state. It clearly records all the evidence.



The presentation of the White Paper **«Protection** of Children from Forced Displacement and Deportation» took place on August 27, 2024. This is the first document developed by the International Expert Group Bring Kids Back UA.





In addition, Andriy Chernousov took part in a comprehensive assessment of the child-friendly justice system in Ukraine. This assessment is the result of a study conducted in September-December 2023 by a team of international and national experts within the framework of the Council of Europe project **"Protection of Children's Rights during War and Post-War in Ukraine"**. The assessment contains information on the observance of the rights of children in conflict with the law, victims of crimes or witnesses of them, as well as on cases involving children in civil and administrative proceedings. The study examines the implementation of child-friendly justice standards, identifies the main trends and key problems in ensuring the procedural rights of the child in criminal, civil and administrative cases involving children and protecting their rights and interests, and offers recommendations on the main areas of child rights protection, including practical solutions to the identified problematic issues.

INTERESTS AND PUBLIC ACTIVITIES OF UKRAINIAN YOUTH

In the fall of 2024, the KhISR conducted a survey of young people aged 18-26. The sample consisted of 763 people. The results showed that today young people are not very actively joining various youth movements, both formal and informal, are poorly informed and not very interested in this activity. However, young people are quite actively involved in public activities, mainly of a volunteer / charitable or sports nature. At the same time, there are few youth work centers - clubs, circles, student self-government, youth centers / spaces, youth councils, etc. A greater variety of forms and proposals is needed, taking into account the interests of modern youth. Among the most priority areas are sports, professional orientation and assistance in employment, creativity, psychological support, learning foreign languages, entertainment and educational activities (concerts, excursions, hikes), etc.
